

CHAIRMAN'S REVIEW



The 2011/2012 year proved to be a continuation of the challenges that have beset the racing industry in recent years and our organisation in particular. Competition for sponsorship in a Rugby World Cup year, subdued economic activity and competition for the recreational spend, all placed considerable pressure upon RACE.

Pleasingly though, as a result of much hard work by our member clubs and sterling efforts by the RACE staff and those at Creative Catering, RACE is able to report a surplus before depreciation and impairment of \$207,873. This figure, while somewhat short of our budgeted surplus, in my view, represents a satisfactory result given that the insurance expense for our organisation was approximately \$100,000 ahead of budget and over \$160,000 ahead of what was paid in 2011. Apart from interest and salaries and wages, insurance premiums represent RACE's largest expense item. During the year, New Zealand Thoroughbred Racing initiated a project to consider alternative insurance arrangements for New Zealand's Thoroughbred Racing clubs. Hopefully that project may provide some relief in coming years, although we understand that we cannot expect to see any benefits prior to the 2013/2014 year.

RACE continues to run without a CEO. Given the delicate financial position of our group, your Board has determined to continue with the current management team of Ryan Ayers, Darin Balcombe, Brent Wall and Chris Allen. This structure, while not ideal, has worked well thus far and will be maintained until RACE's finances improve.

Acknowledgements

I am indebted to Ryan, Darin, Brent and Chris for the efforts they have made this year. They have been operating in a tight environment and our group extends our thanks to them for their efforts and dedication.

On a wider front though, I would also like to thank all of the RACE staff for their efforts. This past year has not been easy but their dedication and effort have been superb.

Creative Catering has performed well during the 2011/12 year

and our thanks go to Lewis and his staff for their input and focus upon excellence. This business provides a significant contribution to the well being of our organisation.

The catering and functions part of our business at Trentham (Trentham Gardens) showed improved performance during the year. We are now seeing the benefits of the renovations undertaken to the Carbine Room at Trentham and with careful oversight of the business and the enthusiasm of Stephen Chamberlain, this business looks well placed to improve its contribution.

I must also extend my gratitude to the committees of all of our member clubs. Their enthusiasm, dedication and hard work are vital to the success of RACE. Without their sponsorship gathering activities and the careful stewardship of our member clubs, RACE could not continue to function. In the past 6 months or so, I have had remarked to me on a number of occasions, how meetings conducted by RACE member clubs have a different atmosphere to those experienced at other courses. A convivial, warm and enjoyable atmosphere has been remarked upon. Clearly the close input of our clubs and our staff are creating attractive events. In the current environment, where there is so much competition for the recreational dollar, this is an achievement of which we can be proud, but also one that we must maintain and improve

RACE continues to punch above its weight in the New Zealand racing business. There is no one reason for that but rather a combination of high calibre staff, enthusiastic committees, improving facilities, prudent management and loyal sponsors.

Our clubs have achieved a strong and loyal band of sponsors, without whose contribution, our sport could not continue. RACE thanks all of the sponsors involved for their generous and loyal support.

Finances

I have already touched upon a couple of key points with regard to the financial performance of RACE. In general however, our financial position remains extremely tight. Your committee is very focussed upon debt reduction and it

is pleasing to report that after a soft patch, section sales at the Oaks subdivision have come to life with the result that we have only 7 sections uncommitted. A number of our unconditional sales have yet to settle but over the next 6 months, RACE is expecting to reduce its BNZ borrowings by in excess of \$1.5 million. The remaining sections are attractive lots and good interest in these is being reported.

A number of initiatives have been advanced to us for the improved utilisation and profitability of our resource at Trentham. In the past month, RACE has formed a subcommittee to explore a number of possibilities with a long term strategic view for the Trentham course. The first steps by that committee will be undertaken in the next few weeks.

Racing

Our race meeting profit for the year comfortably beat budget and was approximately \$200,000 ahead of our 2011 performance. A comparison with other racing organisations in New Zealand makes it clear that RACE out performs the industry as a whole.

Racing conducted by our member clubs was of high quality and the weather gods were reasonably kind to us across the year. Notable winners within our group during the year included Mufhasa, Zurella, Guiseppina, Six O'Clock News, Say No More, Veyron, Artistic and Choice Bro.

Track fee income over our training venues showed a small reduction over the previous year reflecting conservative horse numbers. Our resident trainers continued to perform well nationally, and our congratulations go to them and to our successful member owners.

The Year Ahead

Our balance sheet with its debt burden, continues to provide a significant challenge for the RACE Board. Additionally, it is clear that RACE will not enjoy in the 2012/13 year, industry funding, nor gaming grants, to the extent received in the 2011/12 year. Producing an acceptable budget for the 2012/13 year has been extremely challenging and has continued our focus on cost and expenditure. The section sales to come during the year, will provide some assistance but our land bank is diminishing and some other land sale prospects have been affected by resource management considerations to the extent that they may not produce as had been hoped. It is clear therefore, that your Board needs to explore opportunities at all of its venues to release capital and maximise income. The Trentham Strategic Development Committee is a step in this direction.

Additionally, we continue to focus on improved race day events. Unfortunately, the circumstances within which we must operate are often not helpful to our cause. The 2012/13 year again sees a fresh funding model from New Zealand Thoroughbred Racing. The uncertainties each year relating to the formula upon which NZTR will calculate our funding make it difficult for clubs to develop long term plans. The funding model has changed regularly, which is less than ideal from the point of view of long term strategy. While we appreciate that the income produced by any formula will be susceptible to the financial climate, the changing formulas from year to year provide very little incentive to those who contribute their resources voluntarily to go that extra yard in providing an improved and more profitable event. Individual club effort and the provision of excellence needs to be more clearly rewarded and those rewards made more certain. RACE is extremely fortunate with the human resources spread through its staff and member clubs. Without doubt, they are key to the groups above average performance and I extend my personal thanks to the committees of our member clubs and to our staff for the assistance they have afforded during

On a final note, I must acknowledge the sad passing of our previous Chairman, David Bennett in January of this year. David's passion for the racing industry was unequalled. The contribution that he made to RACE, the Manawatu Racing Club and to New Zealand Thoroughbred Racing in general, was enormous. David was a larger than life character with a great knowledge of our industry with well defined views that he advanced without hesitation. David was one of the personalities that made our industry so colourful. He will be missed. On behalf of the RACE group, our member clubs and the RACE staff, I extend our sympathy and support to David's widow, Estelle and to David's children and wider family.

Manawatu Racing Club (Inc)

My third year as President has been as challenging as the first two years, however it still allowed me to put in place my two main goals while President. These were retiring debt and maintaining our major sponsors. Sponsorship makes our club thrive with enthusiastic crowds attending the race days. It is pleasing to report these goals have been achieved. Again our desire is to bring the very best racing to Awapuni which gives our sponsors the opportunity to fly their flag on raceday and promote exciting racing for all concerned. It is also pleasing to hear that our members are supporting our sponsors and buying their products.

Our race day profits of \$368,447 was the Manawatu RC contribution to the Race Group race meeting profits during the season which exceeded our budget by \$28,000. Again the Function Centre is being utilised on a seven day a week basis with the Silks Lounge being full on most racedays. This lounge is presold on raceday and works very well for our Club.

In the last two years our minimum stakes have been set by NZTR. With the kind support of The Oaks Stud and Rick Williams, we have been able to run the richest Two Year Old Group One race in New Zealand at \$225,000 in the past season. Your Club is very proud to be able to run this prestigious race. Recently NZTR announced stake increases of \$3.2 million for the upcoming season which is very pleasing to us all in the Industry.

We have witnessed some great battles on the turf. The Oaks Stud Manawatu Sires Produce Stakes was won by Choice Bro in a tight finish from Magic Shaft. The Lawn Master Awapuni Gold Cup was won by Riomoral in a thrilling finish. Sponsored again by long time supporter, Steelfort Engineering. I wish to thank John McOviney and his staff for their continued support. This year Higgins moved to take over the Manawatu Classic, a Group Three race for three year olds over 2000m. We saw a top horse in Malandrino take the race out and I wish to pass on our thanks to Bernie Higgins and the Green Machine team for their continued sponsorship of a major race at Awapuni. The Hotel Coachman Manawatu Cup was won by local horse Cassini, thanks to Brendan and Leonie Hapeta, who also sponsored and ran a major charitable golf tournament the day before the Cup. The Fairdale and Goodwood Studs Flying Handicap saw a stunning win by Green Supreme and we wish to thank the Fells, Gerald and Rex, supported by their sons Duncan and William. The Ezibuy Eulogy Stakes saw some of New Zealand's best fillies compete and Zurella take the race. Our thanks goes to Peter and

Gerard Gillespie and Ezibuy for their sponsorship of this race.

The NZ Bloodstock Insurance Manawatu Breeders Stakes was an exciting race with the top race mares competing for black type and this was my personal highlight of the year with my own mare, Rumour Has It Now, narrowly getting beaten by the Auret family's Mini Pearl. The winter jumping season was sponsored by FMG and Manawatu ITM. The FMG Steeples was won by Lord Custom and the Manawatu ITM Awapuni Hurdles by Morpheus.

I have been heavily involved in the Grand Oaks section sales and as I am writing this report for the season ending in July 2012, I have much pleasure in advising the sale of ten further sections in the last six weeks. This has gone a long way to achieving our number one priority in retiring debt. There are now only seven left with a lot of interest in them.

We are proud to say all races run at Awapuni by your club have been fully sponsored. Your club is working with enthusiasm for the upcoming season and are looking at new ways to entertain you and your friends during a day at the races. We welcome your feedback if you have any suggestions you wish your committee to consider.

One of the saddest days of our racing at Awapuni during the season was when news of the sudden passing away of past president David Bennett was announced. A stalwart of the Club, he contributed a tremendous amount of time and effort at all levels of racing. You will remember a moving tribute paid to David and family in the birdcage during the Sires Produce Stakes raceday. We wish to record our sympathy and our thoughts to Estelle and her family. We are considering an appropriate race to be run as a memorial to David.

I wish to pass my thanks onto all the committee and their partners for all the work that they carry out behind the scenes. Thanks must also be passed on to all the owners and trainers for their continued support in racing here at Awapuni. We are averaging over three hundred horses in training at Awapuni in the last season. To race at Awapuni seventeen times during the season and maintain the training facility to such high quality is a credit to Chris Allen and his staff. I would also like to pass on my thanks to Brent Wall and the Awapuni office staff for their hard work in the last season in making sure our racing is run at the highest level here. This coming year is going to be my last year as President and after forty years as a member and thirty four years on the committee, I am retiring and passing on the Presidency.

Feilding Jockey Club (Inc)

Whilst composing this report for the 2011/12 season the opening statement could again be a repeat of the 2 previous years reports and echoing other Presidents' reports. These include the continuation of tough economic times facing the racing industry and a decline in racing betting turnovers continuing at a national level. However at both our club and our group level we continue to put in performances and achieve results which buck this trend. At our level, our 3 successful race meetings were able to contribute a race meeting surplus of \$80,000 which was both up \$2,000 on budget and \$4,000 on last year. Our oncourse turnover, one of the few areas where we can increase returns, whilst \$38,000 below budget, was \$1,000 up on the previous year. These results are on a background of our main day, the Feilding Gold Cup day, almost being a washout. More on that later. Given that, the overall result was a tremendous achievement.

These results can't be achieved without the efforts of your committee, our sponsors and from our members and supporters. This has seen good crowds turn up to our main two meetings with a fantastic walk up crowd on Anzac Day and the Silks Lounge and all other corporate areas bursting at the seams on Feilding Cup day.

As usual we began the season with our marquee day, the Feilding Gold Cup meeting, our premier day. We were primed for a great day with new sponsor, Ricoh, on board for the Feilding Gold Cup, the Silk's Lounge and all other function rooms sold out, the Cup field the strongest for some years and good supporting fields. Unfortunately on Friday down came the rain. This resulted in 76 scratchings and only 65 starters across the 10 races and the resulting effect on turnover. However the day itself turned out fine and the Awapuni track again proved itself with the heavy rating being nowhere like a heavy winter track. As we know, the way the track handles the rain is a reflection on the drainage work completed on the course and the work of Chris Allen and his team. So even with the rain, with all races sponsored and good crowds on course, the day ended up a great success. For the second year in a row the winner of the Ricoh Feilding Gold Cup had local connections. Fazza trained on the course by leff Lynds and owned by Hamish Brown and Wayne MacKenzie was an impressive winner. Our supporting event,

the Courtesy Ford Red Craze Bowl was taken out by the northerner, Indian Sky, again in impressive fashion.

Our ANZAC day meeting saw what can happen with a holiday, sunny weather and a compact 8 race day. The crowd support that day was only bettered by the traditional Boxing Day crowd. The Manawatu ITM ANZAC Mile was taken out by Time Keeper winning his second feature race at Awapuni and trained and part owned by Graham Nicholson of Sir Slick fame.

The Club's last day of the season is an industry day, these days back to 8 races per day but with reduced entries, a 7 race programme was held. Mark Pickford again successfully promoted this as a building industry contractor's day.

To run a successful race day and a racing club operation requires all the components of our organisation to both carry out their individual tasks and co-operate together. In doing this I would like to thank my hard working committee and their wives and partners for their efforts, particularly our vice-president Darrin Holm and our sponsorship manager Mark Pickford. I would also like to thank the RACE staff especially Ryan, Brent, Tineke and Chris who we work closely with and who are always ready to assist.

The final thanks goes to our sponsors, to Ricoh & Manawatu ITM who sponsor our main events, the individual sponsors of races and the business house sponsors at our ANZAC Day meeting. As is often said, and the fact remains, that without you we would not be racing in the format we and you enjoy.

The Club and RACE operate within an industry and society that is constantly changing. From an industry perspective we are challenged with new funding and stakes models which often don't deliver what is ideal for us. Our financial situation continues to be a challenge but it is good to see progress being achieved on section sales and investigations into other means of reducing debt. From a Club point of view the tighter economic times challenge our ability to deliver successful race meetings. However with continuing good work from our committee, continuing support from our sponsors and the support of our community we will continue to do this and enjoy doing it.

PRESIDENT'S REPORTS



Rangitikei Racing Club (Inc)

While the Rangitikei Racing Club again had a successful 2011 / 2012 season, the racing industry continues to face many significant challenges. The country's economic times are still very trying with the racing industry focusing on cost control and maximising the recreational dollar.

The Rangitikei Racing Club held two very successful meetings this season, with the November meeting which had two races less than last year, having an on course turnover of \$41,269 and a profit of \$11,646. The Bulls Country Cup, which continues to be sponsored by Scully's products, was run over 2100 meters and won this year by Intransigent from Go Danny.

Our main meeting in May saw the running of the James Bull Rangitikei Gold Cup over 1600 meters which is sponsored by the renowned Bulls racing family, who have guaranteed a minimum stake of \$50,000 for the cup over the next few years. An excellent field of 14 starters contested the cup which resulted in the talented mare Zennista trained by Lisa Latta winning from the Cambridge visitor Nancho Bella trained by Lauren Brennan. The Pattern Review Committee (formerly Graded Stakes) which reviews black type races for the season has promoted the Gold Cup from a second warning to a first warning which in turn provides a measure of security in preventing the race being downgraded. The race day turnover was \$100,010 producing an excellent profit of \$39,469. This was largely attributed to the outstanding turnout of our sponsors in the Silks Lounge room.

The above results reflect the hard work of our committee and we are once again indebted to our sponsors for their continuing support of our race day meetings. With Gerry Scully in charge of sponsorship for the season and with his ongoing drive and enthusiasm along with the support of our loyal sponsors, we saw the Silks Lounge booked out.

I would like to take this opportunity to thank Darin Balcombe, Ryan Ayers, Chris Allen and the staff of RACE for the excellent work they do for the racing industry.

The Club would also like to record with great sadness the recent passing of Dennis Harris. Dennis was President of the Rangitikei Racing Club from 1992 through to 1996 and did an amazing amount of work for the Club. I wish to pass on the Club condolences to the Harris family and he will be sadly missed by us all.

Finally the success of our race days would not have occurred without the dedicated efforts of the committee and I would like to acknowledge the endeavors of my committee and the ongoing support of their partners and wives. A great deal of voluntary time is contributed by the members to make the meetings successful and those contributions are greatly appreciated. A special thanks to my vice presidents John Turkington, Tim Harris, Bryce Newman and Gerry Scully. Regrettably Tom McVerry, Duncan Thomas and David Marshall are standing down from the committee this year and we look forward to welcoming Cam McKelvie into the fold and to another successful racing season.

I would like to make special mention of the staff from Awapuni and Trentham who did a great job organising the children's entertainment on the day, the feedback from the local community has been tremendous and people already have it loaded into their diaries for the coming season.

As previously touched on the Haunui Farm WFA Classic Raceday was again the highlight and focal point of our season. This season Veyron, trained by Linda Laing and ridden by Mark Hills, was a very popular winner of the race, which once again rated very well on the international Group I Ratings. I would like to once again thank Ron and Mark Chitty from Haunui Farm for their tremendous sponsorship of the race, and a special acknowledgement of Shannon Taylor who does a lot of work to ensure a great turnout on the day in the stewards' room. I am especially happy to announce that Haunui Farm are to continue their sponsorship of the Race for another two seasons which is tremendous and gives the club the stability to plan the growth of the day into the future.

The Club also had a Maori Television crew present on the raceday and were recently featured on the channel in a half hour show called "Hoiho" which focused on Horse Racing and Maori, this was particularly timely as it featured an interview with Jim Winiata. We were very appreciative of the channel for attending our raceday and the show was a great promotion for the unique Otaki-Maori Racing Club

The club would also like to make special mention of Mark Benton and Mediaworks who have once again been great sponsors, and done a great deal in the promoting of our racedays, The Dominion Post, and Long Time Supporter Pat Baker from El Cheapo Cars for his long standing sponsorship of the iconic Raukawa Cup raceday.

The Club achieved a very pleasing raceday profit of \$133,193 which was ahead of budget in what was a challenging year globally. Unfortunately training numbers at the course for the season were down quite significantly but I note that in the past couple of months these look to be returning to very positive levels. The Club continues to struggle for funding to support infrastructure but would like to thank the DIA Racing Safety Fund and NZ Community Trust for their support over the past season, funding these projects is always a struggle but with a new initiative from NZTR in an Infrastructure Fund may help Clubs to continue to improve our facilities, both for Racing and also for our patrons. We have also been supported by the NZ Racing Board in this manner by way of 10 new 32 inch TV's for on-course viewing.

Finally I would like to thank the stewards of the club and their partners for their support and the hospitality they provide all patrons of the course. Special thanks to Rangi Ransfield and Tom Jamison for their work and support on the RACE Board. I would like to note for the first time that the Club has a raceday on Melbourne Cup Day, and I ask that our members get right in behind this day so we can grow an annual event on what is one of the most important racedays in Australasia.

PRESIDENT'S REPORTS



Wellington Racing Club (Inc)

With the assistance of the best season weatherwise for many years the Club continued to make a substantial contribution to the RACE Group. On course turnover and contribution to racing profit were pleasing having regard to the generally challenging economic circumstances. Our key racing days all performed creditably and we no longer just rely on Wellington Cup day for our financial return.

Our major races were won by quality horses. Mufhasa (Captain Cook), Ocean Park (Wellington Stakes), Guiseppina (Telegraph), Artistic (NZ Oaks), Six O'clock News (Wellington Cup) and Say No More (Thorndon Mile).

First warnings recently received from the New Zealand Pattern Committee for both the Telegraph Handicap and the Thorndon Mile are a concern and strategies need to be developed to improve the quality of the fields for these races. It would be a tragedy if these races were to lose their Group One status.

The environment is challenging in attracting sponsorship but I recognise the significant achievement of committeeman Des Coppins who has brought in over \$500k in new sponsorship in the last two years- an outstanding effort.

Our thanks to Pacific Jewellers for partnering the Wellington Cup Carnival and instigation of the successful 'Pin to Win' competition with Mary Potter Hospice being the recipient of the proceeds. It was fantastic to have GT Continental support the Fashion in the Field. Our thanks to Josh Mossman for successfully organising the Stella Artois Pavilion in the centre of the course on Cup Day.

Trentham Gardens had a significant turnaround in trading results for the year with a number of new events – Rugby World Cup Campervan site, Creedence Clearwater Revisited concert, Pet Show, Computer interface Expo and many others. The upgrade of the Carbine Room has resulted in a significant increase in weddings and functions. Thanks to Stephen Chamberlain and his TG team for their sterling efforts.

Thanks to all the committee and race day stewards for their support and efforts through the season.

The racing industry is facing a number of challenges that will exercise the mind of the new President David Butler and his committee. The economic pressures facing all stakeholders in the industry are significant.

Some of the key issues are:

- The need for higher stakes a quantum leap will not happen until the NZ Government follows the Australian lead and jointly invests in a "famis" type scheme.
- Enhanced racing facilities and infrastructure to better meet the public expectation. A lack of investment in recent years is making our facilities look tired.
- Poor attendance by the general public outside of Wellington Cup Day.
- The gambling amendment Bill will have a significant impact on racing if it is approved in its current form.

My heartfelt thanks to members for giving me the privilege of being your President for the last three years. I have enjoyed my II years on the Committee and the opportunity to be involved in an industry that I am so passionate about – thank you.

RACING REVIEW



The RACE Group of Clubs would once again witness some on New Zealand's best racehorses grace their tracks in the 2011/2012 season. The Group would hold 41 racedays with two extra days picked up while the Rugby World Cup was being held.

The first Group race for RACE occurred at Awapuni for the Marton JC. The Group Three, \$70,000 Merial Ancare Metric Mile was again a very impressive line up and run on a beautiful Spring track with Dead 4 conditions. Two lengths would cover the first six horses at the line with the Richard Otto trained Our Foreign Minister having a short head to spare over No Excuse Maggie.

Unfortunately a Heavy II track would again affect the Wellington RC Labour weekend raceday. The Stephen McKee trained Silver City would secure the first black type race on the programme taking out the Listed Wellesly Boutique Hotel Stakes. In the hands of Sam Spratt she would have a short head to spare over another northern runner in Seleno. In the Group Three Rich Hill Stud Thompson Handicap, the Richard Joostens trained Bragato would take out an easy win. He gave jockey Matt Cameron an armchair ride and would score by four and a half lengths over No Excuse Maggie. In the final feature of the day the Group Two New Zealand Bloodstock Wellington Guineas, the Central Districts trained runners would fight out the finish. It would be jockey Kelly Myers who would beat her sister Rosie, when scoring upon the Lisa Latta trained President Lincoln. At the line he would have half a length to spare over the Kevin Myers trained Micken. For racegoers this would be President Lincoln,s last race in New Zealand having being purchased by Hong Kong clients and eventually winning there in May.

For the Feilding JC rain would provide a big impact on the days racing with 76 scratchings on race morning just leaving 65 runners on the days programme. The local Fazza, prepared by Jeff Lynds would take out the Ricoh Feilding Gold Cup while northern visitor Indian Sky would secure the Courtesy Ford Red Craze Bowl in the other feature race on the day.

In December the Group One \$200,000 Captain Cook Stakes would see New Zealand Horse Of The Year Mufhasa gain an authorative victory. Given an easy time in front by Sam Spratt

he proved too good in the run home to win by a length and a quarter from Vonusti and Dating. This would be Mufhasa's eighth Group One win in total and his third Group One at Trentham. He would go on to claim another Group One in Australia in February.

The three day Manawatu RC Christmas race meetings were dominated by the locals except for one of the black type races. That would come on the first day where the Cambridge trained Zurella would take out the Group Three \$70,000 Ezibuy Eulogy Stakes for Cambridge trainer Shaun Ritchie. She would defeat a top class field with less than a length covering the next three including top fillies Testa Secret, Capital Diamond and Abeautifulred.

The second day of the carnival saw the track improve from a Dead 5 through to a Dead 4 during the day. The Group Three \$70,000 Hotel Coachman Manawatu Cup was won by the local Cassini. The finish would be a reversal of the result a year earlier with Tullaroan running second. Trainer Mark Oulaghan would be recording his first Manawatu Cup success. Two races later another local in Justanexcuse would easily despatch a top field in the Group Three \$70,000 Harcourts Challenge Stakes. This would be the first black type win for the gelding prepared by Lisa Latta. This would be the second of the three Lisa Latta trained winners on this Premier raceday. Other impressive winners on the card included the 2YO Irish Rebel and 3YO Nashville.

A Slow 7 greeted runners for Marton JC Premier raceday in January. The Listed \$55,000 Gallagher Marton Cup was won very easily by Crocodile Canyon. After sprinting clear on the turn the Kevin Myers trained runner would be eased up before the post by Rosie Myers to score by seven lengths. South Island visitor Aussieaussieaussie would head the remainder. Earlier in the day Say No More would clinch victory in a Rating 85,1600m race to secure her spot in the Group One Thorndon Mile at the Wellington Cup Carnival. The Waikato Stud Handicap would see the very consistent performer Sadist win for John Sargent and also confirm his spot in the Thorndon Mile later that month.

This years Wellington Cup Carnival, while not having a \$IM on the card, still provided some top class racing with the Australian raiders in attendance again as well as big crowds.

The Group One \$300,000 J&N Berkett Telegraph Handicap was taken out by Guiseppina after a gem of a ride from New Zealand's best James McDonald. Australian visitor Atomic Force would run second with El Chico filling the placings. The race was action packed with Durham Town being checked and losing rider Vinny Colgan from the saddle two hundred metres from home. Six O'Clock News would return to the winners circle after a long absence with a win in the Group Two Mills Reef Winery Trentham Stakes run at set weight & penalties conditions. This would provide Australian jockey Nash Rawiller his only win on the day. The Group Three Wellington Stakes would see up and coming colt Ocean Park win very easily with a copybook ride by Chad Ormsby. The Group Two Little Avondale Stud Wakefield Challenge Stakes would see the most breathtaking win of the day, with Pussy Willow in the hands of Sam Spratt coming from an impossible position with two hundred metres to go and win by half a length over Hazel. The Listed Konami Anniversary would see an upset with the Karen Zimmerman trained Fairway Wish holding off all challenges down the straight.

Pacific Jewellers Wellington Cup day brought a good track and a fine day. Quinessential would defeat a high quality field in taking out the \$70,000 Group Three Tiger Prawn Desert Gold Stakes grabbing Capital Diamond in the very last bound. Quinessential prepared by John Sargent would go on to take out the Queensland Oaks in the autumn. The \$200,000 Group Two Pacific Jewellers Wellington Cup saw Six O'Clock News back up from his win in the Trentham Stakes a week earlier to claim the Cup from the 2011 victor Spiro. With Nash Rawiller not choosing to come back to NZ to ride him, Leith Innes picked up the winning ride. It was a childhood dream come true for Innes who commented after the race that this was a race he had dreamt of winning since a young age. The Group One Harcourts Thorndon Mile would see Rosie Myers secure her second career Group One with victory aboard Say No More. Say No More had some inspired support on the tote before the race and the punters were proved right as the Paul Duncan trained mare dashed away from Postmans Daughter and letset Lad.

The Haunui Farm Otaki-Maori Group One WFA again rated as one of New Zealand's leading races during the season. And this years version provided a great spectacle as Veyron downed Lady Kipling and Guiseppina This would be the

second of three Group One victories for Veyron during the season. Mark Hills would ride the horse to victory on the day with the horse having a different jockey in all three Group One wins.

The autumn arrived and the Wellington RC Ladies Day had an outstanding field of fillies gather in the Wellfield New Zealand Oaks. It would prove to be a Shaun Ritchie and Oaks Stud benefit with Artistic and Zurella fighting out a titanic finish with just a nose separating them. Both were owned by the Oaks Stud and trainer Shaun Ritchie did an outstanding job to have them at their peaks for the race after both horses took different paths to Wellington. It would be the nose of Artistic that would be in front as they hit the line and another New Zealand Oaks for jockey Michael Coleman. Floria would give Stephen McKee the first of his two black types wins on the day in the Shinko King@ Paxton Park Cuddle Stakes. He would also have Eight Schillings win the Listed Sakhee's Secret Melbourne Racing Club Lightning Stakes later in the card. Visiting Australian jockey and ex- kiwi Damian Browne would take out the Listed Dixon & Dunlop St Leger on the Chris Wood trained Guns At Five.

At the end of March is one of the best Autumn racedays in the country at Awapuni for the Manawatu Racing Club. The Oaks Stud Stallions Manawatu Sires Produce Stakes is the richest Group One two-year-old race in New Zealand and drew the best horses from all over the country. It would be New Zealand Premiership winning trainer John Sargent who would quinella the Group One race with Choice Bro defeating Magic Shaft and Warhorse close up from the Jason Bridgeman stable in third. Being a former trainer at Awapuni it provided John Sargent a big thrill as well as local jockey Jonathan Riddell who was winning his first Sires. The Group Two \$85,000 Lawnmaster Awapuni Gold Cup would see a longshot in Riomoral lead all the way for an upset win of odds of 45-I. Malandrino would destroy an even line up on the Group Three \$70,000 Higgins Manawatu Classic in the hands of James McDonald and the promising Green Supreme would take out the Listed \$45,000 Fairdale/Goodwood Studs Flying Handicap.

The New Zealand Bloodstock Insurance Manawatu Breeders would see another upset winner in the Fraser Auret trained Mini Pearl. She would prevail in a very tight finish with a length and a half covering the first seven horses home.

Winter racing would see the local Zennista prepared by Lisa Latta take out the Listed James Bull Rangitikei Gold Cup at the Rangitikei RC May meeting. The jumping action proved to be as exciting as ever. In June at Awapuni the locals would take out the FMG Manawatu Steeplechase with the Grant Searle trained Lord Custom winning in the hands of local rider Gary Walsh. The Manawatu ITM Awapuni Hurdle would see Morpheus put up an impressive display in the hands of Richard Cully to defeat a quality field. In July Waitaha Toa would take out the Wellington Hurdles after a top ride by Jonathan Riddell. While he only rides very sparingly over the fences now days, Riddell showed he was still one of the best in this department with an impressive display. Toms Myth would impress many with his win in the Grant Plumbing Wellington Steeplechase for trainer Ann Browne. We have seen how good a jumper Toms Myth is in the new season already with his great win in the Great Northern Steeple at Ellerslie recently.

FINANCE REVIEW

RACE has achieved a net surplus of \$207,873 before impairment and depreciation for the year ended 31 July 2012. This compares to a \$386,822 net surplus last year. After depreciation and impairment the recorded loss for the year is \$604,940 compared to a loss of \$886,771 in 2011.

The budget for the 2012 year was \$340,387 (before depreciation), which results in an actual negative variance to budget of \$132,514. The majority of this variance (\$100k) can be attributed to the substantially increased insurance premiums we paid this year. The insurance budget was increased by 50% from last year, but we didn't foresee the Wellington premiums tripling. We were forced to reduce cover across all three tracks to get the premiums down but in the end still paid twice the 2011 amount.

Another large unbudgeted cost was the renewal of the Awapuni and Otaki water consents which cost \$32,000 in total. We also recorded a loss of \$18,645 on the sale of five Grand Oaks sections, however if must be stressed this is a book loss only and doesn't represent an actual cash loss.

Race Meeting Statement

The surplus from racing of \$2,175,445 easily surpasses last year's result (up \$200k) and is in fact the second highest profit that RACE has ever generated from racing, beaten only by the record 2010 season. The great result is also well ahead of budget and can be attributed to three things: First, the outstanding efforts of all the club committees to get every race we run sponsored whilst also encouraging large numbers of people oncourse; second, the weather — we had no days severely impacted by weather this year; and third, the efforts of management in successfully running these racedays and keeping costs under control. Proof of how well RACE performed can be signalled by our bonus oncourse turnover commission payment for the season which totalled \$186,610. We had budgeted to receive \$50,000.

Catering

Creative Catering had a very successful year, returning a profit of \$313,270 on a budget of \$287,461. While the result is below last year this was expected as over \$150k of turnover was forfeited with the Otaki & Levin raceday catering transferring to Trentham Gardens and the catering agreement for Woodville racecourse not being renewed this season. Despite this, total turnover was again over \$2m for the second year running and function (non raceday) turnover was up 25%.

Trentham Gardens has shown a remarkable turnaround from last year, almost doubling profit to \$118,445. On top of gaining the Otaki and Levin raceday catering as mentioned above, non raceday turnover grew by \$265k (up 136%). The recently renovated Carbine Room is proving to have been a good investment. Whilst the result against last year is encouraging, it is not all rosy as budget was missed due to some expenses coming in over budget, namely casual wages and hireage costs. This issue is a major focus for Trentham Gardens management in 2013.

Grand Oaks Development

Little interest was shown for most of the year in the Grand Oaks development however that changed in July. Five sections sold in the last week of that month and have been realised in this year's accounts. Since balance date another five sections have gone unconditional with four of these settling within the next six months. It would be fair to say interest in the development is very strong and we are hopeful of selling the remaining seven sections in the next few months.

Track and Training

Net track and training costs amounted to \$276,343. This was \$51k over budget which can be attributed to the water consent costs as mentioned earlier, insurance, slightly higher wage costs and higher than budgeted sand costs across all three tracks. Total track fees revenue decreased by \$20k from last year to \$390,081.

Financing Costs And Debt Position

It is no secret that RACE's high debt level and therefore its high interest burden (also add to that insurance premiums these days) is really holding the Group back from really realising its full potential. Having said that interest paid this year of \$586,526 was lower than last year even though minimal debt reduction was achieved. We will however be reducing bank debt by around \$1.5m over the next few months on the back of the recent Grand Oaks section sales. This equates to reduced holding costs of about \$100k per year.

Cash Flow Statement

The cash flow statement on page 22 shows just how tight a ship RACE operates. Whilst the entire business generated turnover of some \$17.4m, the operating cash surplus was \$629,794 and the overall cash loss for the year was \$866. This compares to an operating cash surplus of \$571,431 and an overall cash surplus for 2011 of \$42,442. Cash is king and maintaining a positive cash flow is essential to the Groups' survival.

Balance Sheet

Cash on hand/bank accounts at balance date total \$450,476. While this may seem a "healthy" balance cash reserves can run very low during our quieter months so a buffer is required.

Stock on hand is \$202,160 at balance date which is \$41,732 lower than July 2011. Over stocking has been an issue in the past so it is pleasing to see the Catering Managers reducing carrying levels and continuing to do so.

Total debt is just over \$11m, slightly less than at July 2011. We expect to see a significant reduction in this figure by 31 July 2013.

NOTES TO THE ACCOUNTS 2012

Note I - Statement Of Accounting Policies

Reporting Entity

Racing at Awapuni, Otaki and Trentham Combined Enterprise Incorporated (RACE Inc) is an incorporated society established under the Incorporated Societies Act 1908.

RACE Incorporated is a formal partnership between the Manawatu Racing Club, Marton Jockey Club, Feilding Jockey Club, Rangitikei Racing Club, Wellington Racing Club and the Otaki-Maori Racing Club.

General Accounting Principles

These Financial Statements are prepared in terms of Section 28 (2) of the Racing Act 2003 and generally accepted accounting practice in New Zealand with the Racing Act having preference.

The general accounting principles recognised as appropriate for the measurement and reporting of results and financial position on an historic cost basis have been consistently followed except as specifically mentioned below.

Specific Accounting Policies

RACE Incorporated qualifies for differential reporting as it is not publicly accountable and it does not qualify as large. The Society has applied the differential reporting exemptions allowed in relation to the following standards:

- FRS 10: Statement of Cash Flows (with the exception of a Cash Flow Statement as presented)
- FRS 31: Disclosure of Information about Financial Instruments

Accounts Receivable

Accounts receivable are stated at net realisable value.

Stock on Hand

Stock on Hand is valued at the lower of cost and net realisable value.

Property, Plant & Equipment

Property, Plant & Equipment is stated at acquisition cost to RACE Inc. Depreciation is provided at rates to write the assets off over the estimated life of those assets.

Kitchen Equipment is stated at acquisition cost and all replacements are written off in the year of purchase.

Property Intended for Sale

Property Intended for Sale is stated at the lower of cost and net realisable value.

Investments

Investments are stated at the lower of cost and net realisable value.

GST

All transactions are recorded exclusive of GST and the refund due as at 31 July 2012 is included under Current Assets in the Statement of Financial Position.

Changes in Accounting Policies

There have been no changes in accounting policies for RACE Inc during the period covered by these financial statements.

Note 2 - Borrowings

Bank of New Zealand

The term loans of \$7,505,194 relate to an \$8.82m facility arranged with the bank on 17th December 2008. This facility is for a period of five years, with a condition that all Grand Oaks section sales monies are utilised in reduction of this debt. The terms and interest rates are as follows:

- \$ 3,000,000 loan Maturity date: 29 July 2013. Interest rate: 7.20%
- \$ 3,000,000 loan Maturity date: 27 December 2012. Interest rate: 5.05%
- \$ 1,000,000 loan Maturity date: 24 September 2012. Interest rate: 5.15%
- \$ 505,194 loan Maturity date: 28 August 2012. Interest rate: 5.10%

The following guarantees are provided for the above loans:

- \$12,000,000 Manawatu Racing Club, Wellington Racing Club, Rangitikei Racing Club, Feilding Jockey Club, Marton Jockey Club & Otaki-Maori Racing Club
- \$8,820,000 New Zealand Racing Board.

The Bank of New Zealand holds first registered mortgages over Awapuni, Trentham and Otaki racecourses as well as property situated at Shirriffs Road and Pioneer Highway, Palmerston North and a perfected security interest in all acquired property of RACE Inc.

New Zealand Thoroughbred Racing

The value of the NZTR Trentham track loan at balance date is \$369,827. The repayment date of this loan is to be agreed at a later date. The interest rate is 3.50%.

The value of the NZTR Otaki track loan at balance date is \$148,219. The repayment date of this loan is to be agreed at a later date. The interest rate is 3.50%.

New Zealand Racing Board

The NZRB has provided RACE with a \$3m five year working capital facility. As at balance date this facility was drawn to \$2,875,000 with accrued interest of \$116,072. The interest rate is 3.50%.

The NZRB holds second priority registered mortgages over Awapuni, Otaki and Trentham racecourses.

Note 4 - Investments

RACE Inc on behalf of the six member Clubs is a member of the Central Districts Cluster Partnership and holds an investment of \$58,128 (2011 - \$37,787).

Note 5 - Commitments

RACE Inc entered into an agreement on 26 August 2011 for the lease of new IT equipment at Awapuni and Trentham. The term is 36 months.

RACE Inc entered into an agreement on 5 May 2011 for the lease of two new photocopiers at Awapuni and Trentham. The term is 60 months.

Note 6 - Related Parties

Board member David Butler is a partner of law firm Gillespie Young Watson who have provided legal services to RACE during the year.

Board member John Henderson is a partner of law firm Evans Henderson Woodbridge who have provided legal services to RACE during the year. RACE has also purchased products from Ravensdown Fertiliser Co-op Ltd of whom John Henderson is a director.

Board member Graeme Martin is the owner of Martin Engineering who supplied and installed electronic gates at Awapuni during the year.

Various Board members and their associated entities may have also provided sponsorship monies for race meetings during the year.

All of the above transactions are within the normal conditions of trading.

Note 7 - Contingent Liabilities

There are no known contingent liabilities as at balance date (2011: Nil).

Note 8 - Revenue

Race Inc had a total income for the 2012 year of \$17,375,133 (2011 - \$17,753,449). Included in this is \$1,100,087 (2011 - \$1,054,388) of charges between the various RACE divisions.

Note 9 - Earthquake Prone Buildings

Wellington Racing Club has received notification from Upper Hutt City Council regarding the assessment of earthquake prone buildings. RACE has significant building infrastructure at Trentham with a book value of \$7.95m. The Upper Hutt City Council assessment indicates that most buildings are below the minimum safety threshold and for financial reporting purposes this could result in a significant impairment to the valuation of these buildings. An exercise to assess the value of any impairment for these buildings has not yet been carried out and therefore the associated financial impact cannot be quantified in these financial statements.

Note 10 - NZ 2011 Festival Lottery Fund Grant

During the year RACE received a grant of \$7,685 from the NZ 2011 Festival Lottery Fund for the festival activities held at Trentham during the Rugby World Cup.





INDEPENDENT AUDITOR'S REPORT

To the Members of Racing at Awapuni Combined Enterprise Inc (RACE)

We have audited the financial statements of RACE, which comprises of the statement of financial position as at 3 | July 2012, the statement of financial performance, the statement of movements in equity and cash flow statement for the year then ended. These include a summary of significant accounting policies and are prepared in accordance with Section 28 (2) of the Racing Act 2003.

Boards' Responsibility for the Financial Statements

The Board is responsible for the preparation and fair presentation of these financial statements in accordance with generally accepted accounting practice in New Zealand and for such internal control as the Board determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with International Standards on Auditing (New Zealand). Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates as well

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Other than in our capacity as auditor of Wellington Racing Club, Rangitikei Racing Club, Otaki Maori Racing Club, Manawatu Racing Club, Marton Jockey Club and Feilding Jockey Club, we have no relationship with, or interests in, RACE.

Basis for Qualified Opinion

As disclosed in the financial statements in note 9, Wellington Racing Club has received notification from Upper Hutt City Council regarding an assessment of earthquake prone buildings. RACE has significant building infrastructure at Trentham with a book value of \$7.95m. The Upper Hutt City Council assessment indicates that most buildings are below the minimum safety threshold and for financial reporting purposes this could result in a significant impairment to the valuation of these buildings. An exercise to assess the value of any impairment for these buildings has not yet been carried out and therefore the associated financial impact cannot be quantified in these financial statements.

Qualified Opinion

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the financial statements present fairly, in all material respects, the financial position of RACE as at 31 accepted accounting practice in New Zealand and Section 28 (2) of the Racing Act 2003.
